

NONDISCRIMINATION NOTICE

Discrimination is against the law. Ventura County BHP follows State and Federal civil rights laws. Ventura County BHP does not unlawfully discriminate, exclude people, or treat them differently because of sex, race, color, religion, ancestry, national origin, ethnic group identification, age, mental disability, physical disability, medical condition, genetic information, marital status, gender, gender identity, or sexual orientation.

Ventura County BHP provides:

- Free aids and services to people with disabilities to help them communicate better, such as:
 - Qualified sign language interpreters

- Free language services to people whose primary language is not English, such as:
 - Qualified interpreters

HOW TO FILE A GRIEVANCE

If you believe that Ventura County BHP has failed to provide these services or unlawfully discriminated in another way on the basis of sex, race, color, religion, ancestry, national origin, ethnic group identification, age, mental disability, physical disability, medical condition, genetic information, marital status, gender, gender identity, or sexual orientation, you can file a grievance with Ventura County Quality Management Department. You can file a grievance by phone, in writing, in person, or electronically:
