Update on County of Ventura Automated External Defibrillators (AED) Program/Presentation of Certificates of Recognition—Time Certain: 10:00 A.M.

Dear Members of the Board:

It is my pleasure to introduce a presentation by the Ventura County Public Health Department to update you on the progress of the AED (Automated External Defibrillator) Program in Ventura County. I am very proud of the fact that the Board of Supervisors adopted a progressive and enlightened stance on AED's in this County. In fact, we are one of the only non-federal government agencies to introduce the program--without mandate--for the benefit of the people of Ventura County who not only work in our buildings, but also for those who come to conduct their business here.

The AED Program will undoubtedly save lives in Ventura County as it has wherever AEDs are installed. It goes without mention that a voluntary program like this exists only through collaboration and support from many people and agencies. For this reason, it is my pleasure to present Certificates of Appreciation and Recognition from the Board of Supervisors to those who have made such an effort to facilitate our AED program, immediately following our AED Update.

For your information, the Public Health Department, under the direction of Paul Lorenz, has prepared some background information on the AED's and the County's initiation of the program:

Background:

In the Cardiac Arrest Survival Act of 1999 Congress made the following findings:

> Over 700 lives are lost every day to sudden cardiac arrest in the United States.

- > More than 95 percent of these cardiac arrest victims will die, many because of lack of readily available life saving medical equipment.
- With current medical technology, up to 30 percent of cardiac arrest victims could be saved if victims had access to immediate medical response, including defibrillation and cardiopulmonary resuscitation.
- Automated external defibrillator devices have been demonstrated to be safe and effective, even when used by lay people, since the devices are designed not to allow a user to administer a shock until after the device has analyzed a victim's heart rhythm and determined that an electric shock is required. (Attachment A provides information regarding frequently asked questions about AEDs).

Discussion:

In the last twelve months, the County of Ventura responded to more than 300 calls for people who were experiencing cardiac arrest. In most cases, the only cure for sudden cardiac arrest is immediate defibrillation. If cardiac arrest is involved, four to six minutes without having oxygen to the brain and other vital organs can cause irreversible damage. Due to this, it is important to have automated external defibrillators (AEDs) in as many public places as possible.

The Board of Supervisors recognized the need to review the benefit and possible implementation of AED Program for County facilities and directed EMS to convene a workgroup to develop and make recommendations. The resulting program was presented to the Tobacco Settlement Program Oversight Committees, who recommended \$155,000 for an initial implementation phase of 50 defibrillators in County facilities in their 2001 funding recommendations. The Board of Supervisors approved this allocation of funding to Public Health – Emergency Medical Services to begin developing and administering the County of Ventura AED Program in September 2001.

County of Ventura AED Program:

The County's AED Program has two components. The first focuses on the AEDs to be placed in County facilities. This part of the program is built on County of Ventura employee participation. Employees who volunteer to participate in the program receive four-hours of training in CPR, the use of AED equipment, and how to react to emergencies. More than 450 employee volunteers have been trained, since April 2002, at almost all sites designated to receive defibrillators in the first implementation phase. Employee volunteers must also participate in skills refresher training at six month intervals during their two year certification period.

Placement of AEDs in this initial phase was prioritized by the following factors: number of persons per day (employees and public) at a County facility; nature of work and duties being performed at the location (e.g. remote location, working around high voltage or hazardous materials); and presence of factors inherent in the reason members of the public are visiting specified County locations, (i.e. medical needs). Defibrillators have been placed at the Camarillo and Oxnard Airports, the El Rio Yard, VCMC Urgent Care Clinics, County

Government Center, County libraries, East County Courthouse, and several Human Services Agency and Probation facilities county-wide (see complete listing in Attachment B). The remaining AEDs will be placed in Sheriff Department locations around the County by the end of the month.

Public Access Defibrillation:

Public Access Defibrillation (PAD) is the second component of the County's AED program, and an important step towards improving the survivability of cardiac arrest victims in other facilities within Ventura County. One of the AED Program Administrator's duties is to determine how many public/private entities already have PAD programs and to encourage and assist other entities in establishing such programs. A listing of known Public Access programs in the County is provided in Attachment C.

The Future:

A website has been developed for the County of Ventura AED Program. This website is used to inform and encourage participation by both employees for the County of Ventura and by other companies to set up their own programs. This website may be visited at http://www.vchca.org/ph/ems/aed/index.htm.

Future activities for the AED Program will include continuing to seek funding for the purchase of additional AEDs for County facilities and to provide training for employee volunteers; monitoring employee volunteer participation in skills refresher training; and mailings to public/private employers to encourage them to request additional information from our office on how to start their own PAD program.

ATTACHMENT A

Frequently Asked Questions About AEDs

What does AED stand for?

AED stands for automated external defibrillator (or automated external defibrillation).

What's an AED?

An AED is a device used to administer an electric shock through the chest wall to the heart. Built-in computers assess the patient's heart rhythm, judge whether defibrillation is needed, and then administer the shock. Audible and/or visual prompts guide the user through the process.

How does an AED work?

A microprocessor inside the defibrillator interprets (analyzes) the victim's heart rhythm through adhesive electrodes (some AED models require you to press an ANALYZE button). The computer analyzes the heart rhythm and advises the operator whether a shock is needed. AEDs advise a shock only to ventricular fibrillation and fast ventricular tachycardia. The electric current is delivered through the victim's chest wall through adhesive electrode pads.

Why are AEDs important?

AEDs are important because they strengthen the Chain of Survival. They can restore a normal heart rhythm in victims of sudden cardiac arrest. New, portable AEDs enable more people to respond to a medical emergency that requires defibrillation. When a person suffers a sudden cardiac arrest, their chance of survival decreases by 7% to 10% for each minute that passes without defibrillation. AEDs save lives.

Who can use an AED?

Most AEDs are designed for use by non-medical personnel such as police, firefighters, flight attendants, security guards, and other lay rescuers who have been properly trained. Having more people in the community who can respond to a medical emergency by providing defibrillation will greatly increase sudden cardiac arrest survival rates.

Why does someone having a heart attack need an AED?

When a heart attack becomes a full cardiac arrest, the heart most often goes into uncoordinated electrical activity called fibrillation. The heart twitches ineffectively and can't pump blood. The AED delivers electric current to the heart muscle, momentarily stunning the heart, stopping all activity. This gives the heart an opportunity to resume beating effectively.

Will an AED always resuscitate someone in cardiac arrest?

The AED treats only a heart in ventricular fibrillation (VF), an irregular heart rhythm. In cardiac arrest without VF, the heart doesn't respond to electric currents but needs medications. The victim needs breathing support. AEDs are less successful when the victim has been in cardiac arrest for more than a few minutes, especially if no CPR was provided.
