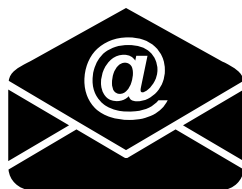

Financial needs assessment may apply. The County will prioritize request based on level of risk. Homes built before 1978, or that are most likely to contain lead paint hazards for other reasons, will be the first to be tested. If we find lead paint hazards the County and it's contractors will work with you (the owner, if you are a tenant) to design and provide abatement work by a licensed lead contractor to remove the hazard depending on the work required and /availability of funds.
